1. Failure to attend class does not signify or imply notification to cancel this agreement.
2. Students failure to continue lessons during the notification or program period does not relieve the obligation to pay the remaining tuition balance in full.
3. Undersigned assumes all responsibility for any costs of collection, including but not limited to reasonable collection fee, court costs, and applicable late charges that may be incurred for default payments.
4. School administrators may make modifications in the class schedule as deemed necessary. Such modification does not relieve of payment obligations.
5. The tuition cost is based on a 4 week month/session.
6. School administrators may close the school on national holidays, and for the purpose of special events, without affecting scheduled tuition payments.
7. Full payment of tuition fees does not guarantee belt certification by school administration, or include belt promotion test fees or special event fees.
8. The school reserves their right to revoke or terminate any membership.
9. The school shall not be responsible for damaged, lost or stolen articles, inside or outside the facility.
10. Enrollee acknowledges that Tae Kwon Do is a contact sport and assumes all responsibility for medical treatment and or injuries.

In recognition of the possibility of accident, injury, or death connected with martial arts training, student waives any right or cause of action of any kind arising as the result of such activity from which any liability may or could accrue to the school, its officers, agents, employees, instructors and/or students
